IN CASE YOU MISSED IT!!

City to save approximately \$1.1 Million by Refinancing Bonds and Loans

The City of Hickman Mayor & City Council are saving the tax payers and utility customers an estimated \$1.1 million in interest by voting unanimously to refinance municipal debt.

Refinancing options of lowered interest rates and reduced amortization schedules were presented by Mr. Brad Slaughter of Piper Sandler & Co. and City Administrator, Ms. Kelly Oelke.

Interest rates will be reduced from
2.36% to 1.14% for the 2016 Water Bond;
3.125% to 2.228% for the USDA
Community Center/City Hall loan;
and 2.50% to 1% for the NDEE Sewer Loan.
